- Suggestion by a CAC member that CAC should be attempting to bring "perspectives," of community and should not be considered to "represent" a group's opinion.
- Is there still a role for the CAC and what is that role?
- Given that role, what does it take to do that?
- Different types of community engagement possible.
 - o continuous issues/outreach
 - o opportunity-specific
- Topics- What does Denver Water need from CAC?
- Consider that CAC has been trying to go a mile wide and an inch deep which makes it
 difficult to have meaningful input and recommendations. Staff suggested having one
 specific issue that the Board asks for input on, while also considering CAC
 interest/expertise. This would not exclude any continuous opportunities for engagement if
 so desired.
- CAC offers lots of expertise, but staff may not be familiar with what that expertise is. CAC could consider providing a summary list to help in topic identification.
- How- Help develop the strategy for DW to implement—identify blind spots, not implementing strategy.
- Alternating informational meetings and business/working meetings was done in the past and perhaps should be reconsidered.

- Mike invited CAC to attend internal meetings, such as the external affairs forum, if
 interested and discussed how Denver Water has a lot of experts who are always happy to
 speak with CAC to do a presentation or to have a one-on-one discussion. Jeannine discussed
 how there also would need to be a process developed by the committee to handle such
 requests so that they are coordinated, and the CAC members are all aware of what
 everyone else is asking.
- CAC interested in exploring meetings every other month instead of monthly.

Bylaw changes and vacancies

6:05 p.m.

- Paul initiated recommended changes to West Slope position and CAC agreed via email that staff would put those forth to Denver Water's office of general counsel.
- The bylaw changes are being reviewed and, in the process, the office of general counsel also recommended some clean-up (grammar, consistency in what CAC is called).
- Discussed timing for appointments to West Slope vacancies. CAC requested that the West Slope candidate under the current bylaws get appointed as soon as possible, then have the bylaw change to at the following meeting, with the second West Slope appointment going to the Board after that. Staff is seeing if this is possible.
- CAC members who were part of the interviews will send Jeannine their top three candidates. The top two approved by the whole committee will be presented to the Board.
- Homebuilder Association of Metro Denver vacancy at end of year. Will need to fill.
- Officers, as well as anyone moving into their second term will need to be voted on in November. CAC may consider adding a secretary position.
